

2021 LSAT Scholarship Application

The LGBT Bar Association Foundation of Greater New York ("LeGaL") is now accepting applications for its inaugural LSAT Scholarship to help defray the costs of a preparatory course and/or examination fees for the Law School Admissions Test (LSAT).

About LeGaL:

Mission: LeGaL is one of the oldest LGBTQ+ bar associations in the country, seeking to improve the administration of the law, ensure full equality for members of the LGBTQ+ community, promote the expertise and advancement of LGBTQ+ legal professionals, and serve the larger community.

As part of our efforts to promote the expertise and advancement of LGBTQ+ legal professionals, LeGaL is seeking to increase the pipeline of LGBTQ+ people entering the legal profession in New York. People who belong to multiple communities historically excluded from the practice of law are especially encouraged to apply. The recipient of the 2021 LSAT scholarship will receive financial assistance to take a LSAT preparation course of their choosing and will be given a premium student membership to LeGaL during their law school journey.

Award:

The total costs/reimbursement are not to exceed \$1,500.00 USD, made payable to the applicable course provider of the applicant's choosing in/after June 2021.

Eligibility:

Must be currently enrolled, or graduated from, a four-year college or university. Must be committed to taking the LSAT in 2021, and pursuing a law degree at an ABA accredited law school with the intention of practicing in New York upon graduation.

How to Apply:

Please enter "2021 LSAT Scholarship Application" in the subject line of the email. Please include in the body of the email your anticipated LSAT test date and law school application cycle.

- Resume or CV;
- Transcript (Unofficial or Official);
- Personal Statement #1: in 500 words or less, describing how you will contribute to promoting LeGaL's efforts as described in our mission statement <u>OR</u> address how membership in past clubs/activities have informed your intent to go to law school and/or how you intend to use your law degree upon graduation; AND
- Personal Statement #2: in 500 words or less, demonstrating financial need and additional barriers to
 educational access, such as lack of LGBTQ+ community support system and/or membership in
 multiple communities historically excluded from the practice of law; and
- Signed Attestation Form.

Deadline:

Applications will be accepted from April 15, 2021 through May 15, 2021.
